SUBJECT: Attendance at Source Selection Briefings

Frequently, members of SAF/AQ organizations are required to participate in source selection briefings as members of a source selection organization. When a source selection briefing is conducted or a meeting is held where source selection information is discussed/disclosed, attendance is limited to only those persons who have been designated as the Source Selection Authority (SSA), as members of the Source Selection Evaluation Team (SSET) or Source Selection Advisory Council (SSAC), or as advisors to the SSET/SSAC; and who have signed the required Source Selection Information Briefing and Debriefing Certificate.

For example, at a competitive range briefing to the SSA or other meeting where source selection information is disclosed, government personnel or support contractors who support or work the program on a day-to-day basis shall not attend unless they have been duly designated as members of the source selection organization. The SSET Chair and the Contracting Officer are responsible for ensuring attendance at source selection meetings is limited to members of the source selection organization. Members of the source selection organization are responsible for ensuring they do not disclose source selection information to anyone not involved in the source selection.
